Response to the Free Press Survey: (published June 30)

- 1. Because the FREE PRESS has a daily circulation of 61,889 and received only 1,426 replies (within 6 days!), "Games proponents could argue more than 60,000 either don't care or PASSIVELY SUPPORT the venture."

 ---WHY DONT WE PASSIVELY OPPOSE THE GAMES? -this is B.I.A. reasoning.

 ---since when is a 2.3% response rate considered invalid? GALLUP

 POLLS operate on a much smaller response rate.
 - THIS IS AN ABUSE OF THE DEMOCRATIC SYSTEM, with <u>passive</u> support or opposition always deemed to be in the interest of GOVERNMENT.
- 2. AL GLEASON: "(The Free Press survey) is too biased to have validity.

 It's written to evoke a NO response". (?????)

 THE FREE PRESS QUESTION: "Are you in favour of the City of London being host to the Pan-American Games in 1991?"
